LATICRETE SUPERCAP, LLC will pay for replacement of its own products and replacement of finishing materials, as well as for labor for the replacement installation, but LATICRETE SUPERCAP, LLC will not pay more, calculated on a square-foot (square-meter) basis, for the replacement than the original purchase price of the portion being replaced. LATICRETE SUPERCAP, LLC will not pay for replacement of any portion of the installation that is not proven to be defective.

In the event that the sole and exclusive remedy described above fails of its essential purpose, the liability of LATICRETE SUPERCAP, LLC is limited to the monetary value, on a square-foot (square-meter) basis, of the original purchase price of the portion being replaced.
